3. Supplementary Regulations

3.1 Event Regulations

The Festival of Speed Canberra event will be conducted under the FIA International Sporting Code including Appendices and the Speed Event Sprint / Lap Dash (Exhibition Circuit), the Motorsport Australia Passenger Ride Activity Policy (MSPRA), the Motorsport Australia Come and Try Policy, these Supplementary Regulations and any Further Supplementary Regulations or Bulletins which may be issued.

Motorsport Australia Permit No. 126/0102/01

This event will include the following non-competition activities:

- Exhibition Circuit
- Show and Shine

Other activities may be conducted at the event that may not be under the conditions and Permit of Motorsport Australia and will be solely the responsibility of the Promoter.

The Organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR.

Protests must be lodged in accordance with the NCR.

The Event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1st, Integrity and Legal, and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au.

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. Further details can be found in the Motorsport Australia Insurance Handbook, available at www.motorsport.org.au.

3.2 Integrity

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at www.motorsport.org.au.

Any Participant including the holder of a Motorsport Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, an Australia y drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia. Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

3.3 Remotely Piloted Aircraft (RPA)

A RPA (drone) can be used at Motorsport Australia permitted event, provided the RPA has been approved by the event organisers, and operated within the guidelines of the Motorsport Australia policy as outlined below:

- The RPA, RPA operator and usage is approved by the Event Organisers;
- The RPA operator or controller is certified by Australian Civil Aviation Safety Authority (CASA);
- Event Organisers advise Motorsport Australia of approved operators, and
- The operator carries their own Public Liability Insurance (PLI). Please refer to the full Motorsport Australia Drone (RPA) Policy, here.

4. Event Entry

4.1 Entry Conditions

The Organisers may refuse any entry in accordance with the NCR.

All entrants must hold a current, unrestricted, unsuspended driver's licence. Learner drivers are not permitted to be entrants.

Circuit entrants must purchase a single event licence (Introductory Licence) from Motorsport Australia as part of their entry. Entrants with existing Motorsport Australia licences will be required to provide these as part of their application.

The driver of the Entrant vehicle must be the registered Entrant for that vehicle. No other person is permitted to drive the vehicle at the Event. Penalties will apply.

All entrants and passengers are subject to the Motorsport Australia members protection policy, including the code of conduct as per the Motorsport Australia NCR.

4.2 Entry fees

Circuit entrants will are required to purchase a single event Motorsport Australia licence (\$60.00 per driver) through the event as part of their entry. Entrants with existing Motorsport Australia licences will be required to provide these as part of their application.

5. Entrant Vehicles

5.1 General requirements

Vehicles must comply with the minimum requirements as outlined in the scrutineering guide in Appendix 10.

Further restrictions may be applied to vehicles that do not comply or entry can be refused on this basis. Vehicles for each event must comply with the Technical Appendix Schedule A and B of the Motorsport Australia Manual, and additional requirements for each driving event entered as outlined below.

Where vehicle requirements differ to those published by Motorsport Australia the requirements as detailed in these Supplementary Regulations will take precedence.

An Open vehicle must be fitted with a minimum of a Motorsport Australia Type 2 Safety Cage Structure as per Schedule J of the Motorsport Australia Manual. An Open vehicle is one without a supporting structure rearward of the windscreen or between the top of the windscreen pillars ("A" pillar) and those of the rear window (if fitted).

The vehicle must hold current and valid Event Entrant accreditation. The driver must be the Entrant registered with the vehicle for any activity, at anytime, during the Event.

All vehicles participating in the exhibition circuit will be doing so under as a demonstration vehicle. And as such are not required to have the following items:

- Extinguisher installed within vehicle
- Tow hook
- Battery and tow identification labels
- Secondary battery security strap
- Battery isolation switch

Each vehicle participating in exhibition circuit must have passed the Event Scrutineering requirements. Driver and passenger in a vehicle must sit in a seat engineered for use and must wear a seat belt.

5.2 Passenger Requirements

Passengers are permitted on the exhibition circuit, at the officials' discretion and must comply with the Motorsport Australia Passenger Ride Activity Policy (MSPRA).

All passengers must be 18 years or over and will be required to sign a Motorsport Australia Passenger Ride Entrant Form prior to their participation. Passengers must report to the event information stand to complete the ride form. The passengers will receive a ride briefing. The passenger will be provided with a passenger

wristband. This wristband must remain fitted for the duration of the Event, or for the duration of their participation as a passenger.

The passenger wristband will be supplementary to a spectator wristband, officials and staff passes. Therefore, you will not gain access into any venues with the passenger wristband on its own.

Entrant/drivers are not required to wear passenger wristbands, as all entrants/drivers have signed a waiver form during the event registration process.

5.3 Replacement Vehicles:

At the sole discretion of the Clerk of the Course, a Driver whose vehicle has broken down may use a replacement vehicle. The replacement vehicle must have had a scrutiny form submitted and passed scrutiny check. It should preferably be in the same class and type as the original vehicle

6. Exhibition Circuit Activity

The Exhibition Circuit area is a bitumen surface surrounded by concrete barriers overlaid with lighting and fencing infrastructure to create the Exhibition Circuit.

The exhibition circuit activity will be conducted in accordance with the Motorsport Australia Speed Appendix, and the below:

- The driver must be the Entrant registered with the vehicle. Subsequent drivers are not permitted.
- Passengers are permitted 18 years or older.
- Drivers and passengers are wearing suitable restraints, suits, helmets and footwear for their vehicle classification

Entrants will enter the exhibition the circuit only when the entrant is green flagged by the start line official.

Whilst on the exhibition circuit, the vehicle driver is required to drive their vehicle:

- 1. In a straight line (mandatory)
- 2. With constant forward motion (mandatory)
- 3. At a maximum speed limit of 120 km/hour (mandatory)
- 4. For a maximum time of 15 minutes per session
- 5. With no tyre delamination (mandatory)

All drivers will be briefed on the flag signals. Most importantly, if the RED flag appears, they must immediately stop and wait for directions from the officials.

These flag signals are defined below:

Flag	Signal
YELLOW	Driver is too slow to 20km hour speed, cannot overtake and must be prepared to change direction, due to a hazard beside or partly on the track
GREEN	Circuit is open for vehicle to enter at normal circuit speeds and activity.
RED	Driver is to stop on the exhibition circuit immediately and follow the direction of
BLACK AND	Final lap, Driver is to exit the track as directed by officials.
WHITE	
CHEQUERED	

A failure to obey these rules will result in disciplinary action.

Any Driver not following a reasonable instruction by an event official or security during the Event may be excluded at the discretion of the Clerk of the Course and Stewards of the Event.

6.4 Compulsory Driver Briefing

Prior to the venue opening to public, circuit entrants are required to attend the driver briefing from the Clerk of Course and Safety Manager.

The briefing will be held at the following times and will include a track walk, safety briefing and offer question time from entrants to ensure clarity on the activity.

Saturday 31st January	1:30 pm	Staging lane / Circuit entry
Sunday 1 st February	8:30 am	Staging lane / Circuit entry

A record of attendance will be kept for this briefing, drivers who have not attended the briefing will not be permitted to participate in the circuit sessions.

6.5 Timing

There will be no official timing of individual laps of the circuit activity at the Event it is for demonstration purposes only.

6.6 Circuit Sessions

Entrants will be allocated two sessions per day, over the two days, to participate in. If track schedule delays occur entrants are ensured a minimum of one session each day available for participation.

Sessions are 15 minutes in length, entrants must be in the staging lane 10 minutes prior to their session. Entrants will be escorted to the staging lane from display areas by marshals. If you miss your marshal time you will not be permitted to participate in your session. PA announcements will be made for session marshalling times.

A speed limit of 10km/hour will apply in the display areas, to and from the staging area and all vehicles are to be marshalled to and from the area via an official.

You may not move session groups without approval from the event secretary or Clerk of the Course.

7. Medical

A dedicated Emergency Medical Response Team consisting of one (1) paramedic and one (1) intensive care paramedic and one (1) ambulance will be onsite during all hours of circuit operations to render medical assistance.

8. Vehicle Recovery

A dedicated specialised tow truck will be responsible for towing vehicles from the Exhibition Circuit that are unable to self-drive. The Vehicle Recovery take direction from the Clerk of the Course and Fire Crew.
